

VINOCOLOR INFORMATION SHEET

How to hide wine spots on your barrels and give your cellars and caves a vibrant cachet!

VINOCOLOR is an original 100% natural red stain manufactured by Lyofal, based in Salon de Provence in the French Riviera. By applying it to their barrels, winemakers bring a brighter color to their barrel facility and hide potential splashes of red wine, while avoiding fungus development. Extracted from red wines and grapes by lyophilization (*dry-freeze*), this high tech stain is food-grade, safe and easy to use.

VINOCOLOR is imported from France and packed in small 100 gram, 500 gram and 1 kg containers.

Directions:

- 1. In a container, add approximately 100 grams of VINOCOLOR to one liter of water. (One liter should cover close to 40 barrels.)
- 2. Stir well.
- 3. For best results, use a firm sponge or brush and apply two to three coats.
